We reported the total computational budget and computing infrastructure in the Appendix section. Some model sizes of black-box LLMs are not officially announced, so we don't present them in the paper

In LLMs, higher temperature typically leads to more diverse generations. However, we observed that this parameter does not affect the final results, so we fix it and report it in Table 2. Besides, we reported the hyperparameters for competing models in the Appendix.

In jailbreak research, it is common practice to omit error bars due to budget constraints and the high time complexity involved in implementing and evaluating competing models.
