Due to the lack of sufficient computational resources, we rented servers to conduct a single round of experiments. In prior experiments and a few repeated tests, we observed that the results were relatively stable, with a clear performance gap between the AC-RS method and the baseline. The experimental fluctuations do not affect the conclusions of this paper.
