This is most clearly demonstrated in Section 4, "Benchmarks and Tools for Trustworthy Medical QA," which is entirely dedicated to discussing these artifacts and their corresponding citations. Furthermore, Figure 1 and Table 1 explicitly list numerous benchmarks and link them to their original creators via citations, which are detailed in the "References" section.*
