The work is evaluated only in controlled simulation settings, without deployment or interaction with real-world users, so we did not identify direct societal or safety risks.

The data used consists solely of synthetic simulation trajectories and environment states without human subjects or language data containing personal or offensive content, so no such risks were identified or discussed.
