Our work presents a methodological contribution (PrefRAG) and a synthetic dataset (SemanticPref) for improving autoformalization in logical reasoning. The research is confined to established academic benchmarks (e.g., ARLSAT, FOLIO) and does not involve human subjects, sensitive data, or realworld deployment. The synthetic dataset is generated from existing public benchmarks and contains no personally identifiable or harmful content. Therefore, we perceive no direct ethical risks or societal harms arising from this work that would require a dedicated discussion section.
