A. Questions mandatory for all submissions.

- A1. Did you describe the limitations of your work?

This paper has a Limitations section.

- A2. Did you discuss any potential risks of your work?

We discuss that the use of semantic embeddings in research risks replacing human judgment with potentially different norms, eliminating income for marginalized crowdworkers while creating artificial standards that could pathologize normal human variation.

B. Did you use or create scientific artifacts? (e.g. code, datasets, models)

The models we used were shared by the authors on the Hugging Face Model Hub.

We use 57 questionnaire items that were carefully developed and validated over many decades by professional psychometricians (we also share them in our code repo).

- B5. Did you provide documentation of the artifacts, e.g., coverage of domains, languages, and linguistic phenomena, demographic groups represented, etc.?

Yes, we discuss in Subsection 3.1 that the questionnaire that we are using has been extensively validated cross-culturally in 49 different countries.

In Subsection 3.1 we discuss the numbers of examples (questionnaire items) and other features of the data that we are using.
