 We recruited 9 annotators known personally to the research team. Each annotator completed a minimal annotation task estimated to take 12 hours. No formal monetary compensation was provided; however, we intend to acknowledge their contributions in the final publication. We recognize that this recruitment method may limit generalizability, and we ensured that participation was voluntary and based on informed consent.

 Informed consent was obtained informally through personal communication with each annotator. We explained the purpose of the annotation task, how the data would be used for research purposes, and confirmed their voluntary participation. All participants agreed to contribute under these conditions.
