Yes. We rely on the publicly available and anonymized World Values Survey (WVS) Wave 7 dataset. It contains no direct identifiers (e.g., names, addresses, emails, phone numbers). We collected no new human data and performed no re-identification. See Section 4.1, Appendix F for details.

Yes. We report the package/model settings: LLMs (GPT3.5Turbo, Llama3.18B, Qwen2.57B, DeepSeekV3) with temperature=0 and identical prompts; RAG uses textembeddingada002 with cosine similarity and topk=3 (5/10 in ablations); 5fold CV; metrics: Accuracy/MAE. See Sections 4.2 and 4.1.2, Section 5.1, and Appendices C, E, and G.
