This is a red-teaming research paper that develops a pipeline for generating synthetic jailbreak data tailored to the vulnerabilities of a target LLM. As such, it leverages queries and jailbreak tactics from the WildTeaming set and evaluates on Harmbench these data may be perceived as offensive in content. (Note that we cite the WildTeaming and Harmbench thoroughly see esp. Sections 1, 4, 5, and References.) As mentioned in our Ethics Statement, we understand that there are risks associated with the dissemination of jailbreak data and a jailbreak generation system, but believe that the benefits that our work would bring to LLM safety outweigh these risks. We are devoted to the responsible development and use of any of our artifacts.
