Our work focuses exclusively on methodological improvements for the Document-Level Relation Extraction task. The experiments are conducted on established, public benchmarks (e.g., DocRED) using standard evaluation metrics. We do not collect new personal data, nor do we release a deployed application that interacts with real-world users. Consequently, we do not foresee any immediate ethical risks or negative societal impacts specific to this work beyond the general scope of standard NLP research.
