

Appendix B: MUC-6 Test Scores

MUC-6 TEST SCORES

This appendix contains the summary score reports for each system in the MUC-6 evaluation. The reports are ordered by task (Scenario Template, Template Element, Named Entity, and Coreference) and secondarily by site (in alphabetical order).

More investigation into system performance may be done on the basis of template-by-template score reports, which detail the performance of the system on each article in the test set. The template-by-template score reports are not included in this appendix.

A brief introduction to reading the traditional MUC score reports for Scenario Template is presented here. Further descriptions of the evaluation metrics and the scoring algorithms used for mapping and scoring may be found in the proceedings in the paper entitled "MUC-6 Scoring Procedures and Evaluation Metrics" by Nancy Chinchor and Gary Dungca. At the end of this introduction, the variations on this score report format for the three new tasks will be discussed.

The first column in the report, SLOT, contains one of the following types of label:

A slot name, e.g. **content**

An object name, e.g. **template**

The word "**subtotals**"

Of the three types of rows, the one of primary interest is the one labeled with a slot name. The rows labeled with an object name may be disregarded. The rows containing subtotals may be of interest to those who want to know the performance on the various types of objects in the template.

The following tallies for the test set are presented in the leftmost columns of the score report:

POS Number possible (**COR + INC + MIS**), i.e., the number of fills in the answer key plus any optional fills allowed by the key and generated by the system

ACT Number actual (**COR + INC + SPU**), i.e., the number of fills generated by the system under evaluation

COR Number correct

PAR Number partially correct (no partial credit was given in MUC-6)

INC Number incorrect

SPU Number spurious

MIS Number missing

NON Number non-committal (null fills generated by system that were also null in the answer key)

The rightmost columns in the report contain the values for the following extraction metrics:

REC Recall = **COR/POS**

PRE Precision = **COR/ACT**

UND Undergeneration = **MIS/POS**

OVG Overgeneration = **SPU/ACT**

SUB Substitution = **INC/(COR + INC)**

ERR Error per response fill = **(INC + SPU + MIS)/(COR + INC + SPU + MIS)**

The first row at the bottom of the report is marked as the **ALL OBJECTS** row and gives the official overall tallies and the overall **REC**, **PRE**, **UND**, **OVG**, **SUB**, and **ERR**. The tallies in the **POS**, **ACT**, **COR**, **PAR**, **INC**, **SPU**, **MIS**, and **NON** columns add up to the **ALL OBJECTS** values, but not all rows are considered. The rows that

are not considered are the object rows (i.e., where the entry in the **SLOT** column is an object name) and the subtotal rows (since they simply sum up the tallies for the scored slots in each object). The scores for the metrics in the **ALL OBJECTS** row are not computed by averaging the scores in the individual slot rows, but instead are computed on the basis of the tally totals contained in the **ALL OBJECTS** row itself.

The remaining rows at the bottom of the report contain scores for the following metrics:

TEXT-FILTER Text filtering (recall and precision for document detection)

F-MEASURES F-Measures (weighted combination of recall and precision scores in **ALL OBJECTS** row)

The formulation of the text-filtering scores is based on the relevant/nonrelevant decisions made by the system for the text as a whole, not on the basis of tallies in the slot rows. Some of the score category columns are used to contain the tallies for these decisions across the test set: **COR** (decides relevant and relevant is correct), **SPU** (decides relevant and nonrelevant is correct), **MIS** (decides nonrelevant and relevant is correct), and **NON** (decides nonrelevant and nonrelevant is correct). Text filtering formulas are therefore as follows: **REC = COR/(COR + MIS)**; **PRE = COR/(COR + SPU)**; **UND = MIS/(COR + MIS)**; **OVG = SPU/(COR + SPU)**.

F-Measure scores corresponding to three different weightings of precision relative to recall are computed. The **P&R** value weights precision the same as recall; the **2P&R** value gives twice the weight to precision; the **P&2R** value weights precision half as much as recall. The general formula is:

$$F = \frac{(\beta^2 + 1.0) \times P \times R}{(\beta^2 \times P) + R}$$

The variation on the Scenario Template (**ST**) score report for Template Element (**TE**) is minor; there is no template object and no text filtering score because the objects are generated independent of any domain (scenario) relevance criteria. The variation for the Named Entity (**NE**) task is much more extensive because more diagnostics are provided. The first table is the same as for **ST** and **TE**. The second table provides scores for task subcategorization, e.g. there are rows for each of the type fills showing how well the system did on subcategorizing an entity as an **organization** as opposed to a **person** or **location**. The third table reports the scores according to which part of the document the named entity appeared in. The sections considered were **HL** (headline), **DD** (document date), **DATELINE**, and **TXT** (text).

The Coreference (**CO**) task is quite different from the other three tasks and the output is also different. The score reports contain only recall and precision scores. The scoring method looks at linkages that define equivalence classes, and the important measure is how many linkages need to be added or taken away to get the correct equivalence class. For a more detailed description of the algorithm used, please see the MITRE technical report entitled “A Model-Theoretic Coreference Scoring Scheme” by Marc Vilain, et al. It provides a solution to a difficult evaluation problem and also offers an elegant definition of recall and precision. There are no F-Measures calculated because they have no sensible definition in this context. Please note that the scores for **CO** are ratios and produce numbers less than 1. To obtain the percentage, multiply by 100. The scoring system output that is valuable for diagnostics on this task is the listing of equivalence classes in the key and response which also includes an indication of the key-to-response mappings (alignments).

SCENARIO TEMPLATE (ST) SUMMARY SCORE REPORTS

Note: Each table is identified by both the site name and the code name that was assigned to the system for the evaluation. Optional runs as well as basic runs are included and are distinguished via extensions to the code name.
