The Responsible NLP Checklist used at ACL Rolling Review is adopted from NAACL 2022, with the addition of ACL 2023 question on AI writing assistance and further refinements based on ARR practice.

C. Did you run computational experiments?

- C1. Did you report the number of parameters in the models used, the total computational budget (e.g., GPU hours), and computing infrastructure used?

- C2. Did you discuss the experimental setup, including hyperparameter search and best-found hyperparameter values?
