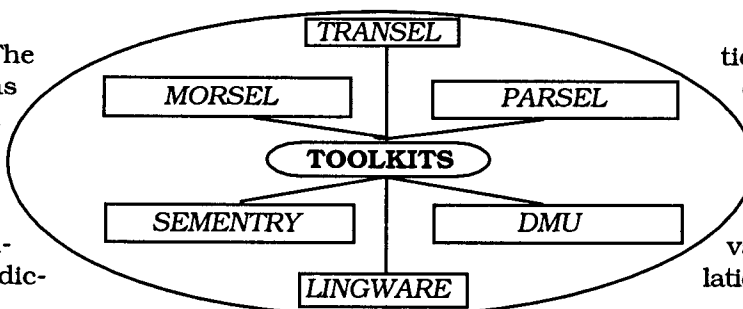

ECS NATURAL LANGUAGE TOOLKITS

The Toolkits provide a set of powerful and flexible tools for the development of natural language systems. Based on Lexical- Functional Grammar, the high-level linguistic formalism can easily be mastered by linguists with no programming experience. The Toolkits contain all the essential elements in the development of natural language processing and machine translation systems, including analysis and translation engines and tools to create lexicons and grammars. Various Toolkits combine modules for specific applications.

Text Analysis The *Parsel* module, a table-driven chart parser, builds c-structures and f-structures, using both top-down and head-centered rules and a unique unification technique that preserves both space and time. The linguist can monitor parsing, watching edges, trees and dags as they are built, with easy access to rules and lexical entries. Ambiguities can be resolved either by user interaction or automatically.

Translation The *TranSel* module has all of the power and flexibility of *Parsel*, but also adds transfer and generation of target language text. The dic-



tionary includes transfer entries that define conditions under which words and constructions of a source language are mapped to various possible translations in a target language.

Morphology *Morsel* is a program which automatically generates the morphology rules based on textbook-style inflectional paradigms. The linguist can also specify allomorphic variation, morpheme class adjacency, and morphemic features.

Lexicons The *Dictionary Maintenance Utility* is a user-friendly tool for adding and updating lexical entries. Using menus, examples, and on-line helps, the user can easily flag morphological, syntactic, and semantic information, including mapping information for translation. An extremely flexible utility can be used to alter the choices presented to the end-user, modifying menus, the size and location of the various windows, headings, labels, values, questions, and selections that appear in *DMU*. Other utilities allow definition of grammar symbols, rules, and standard inheritance entries, as well as optimization operations on the dictionary file system.

Semantic Preference The *Sementry Utility* provides for the creation of semantic preference nets for the resolution of lexical ambiguity.

Lingware The *ECS English Grammar and Lexicon* consist of a mature set of English analysis rules with 15,000 fully flagged English words. Other languages are forthcoming.

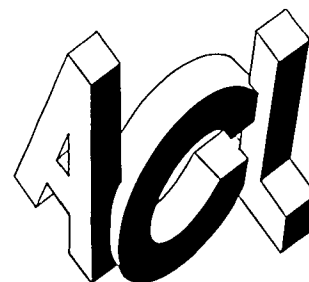

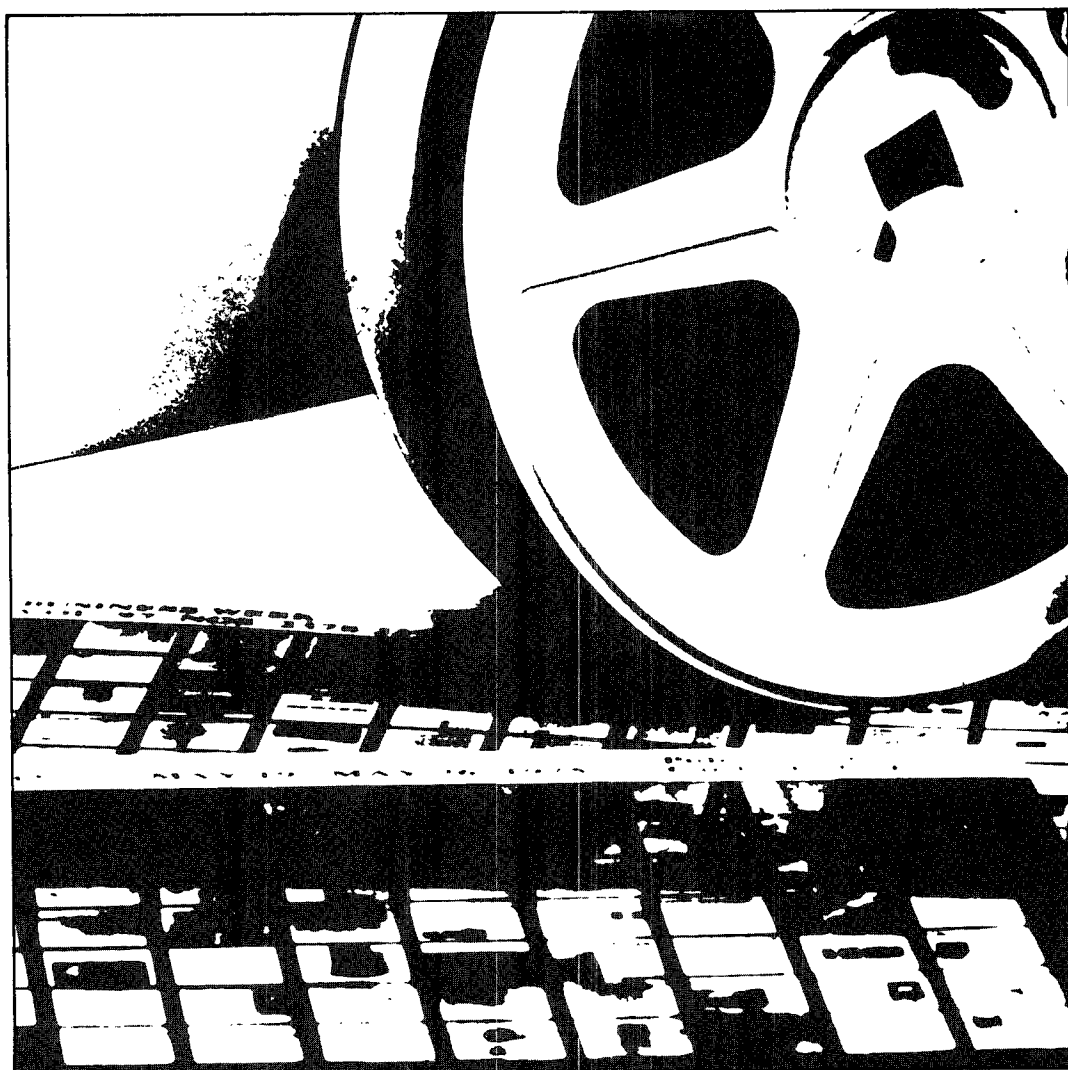

Guidelines for Submissions

Manuscripts to **Computational Linguistics** should be submitted on letter-size paper (8.5 by 11 inches, or A4), double-spaced throughout, including footnotes and references. The paper should begin with an informative abstract of approximately 150-250 words. Manuscripts must be written in English. Contact the editor regarding the possibility of electronic submission.

Submissions may be made in any of the following categories:

PAPER: This category includes contributions that report significant new research results in computational linguistics or that provide critical reviews of the literature on a particular topic. The length of a paper depends on its content, but we suggest that manuscripts be limited to forty double-spaced pages. That is the equivalent of twelve journal pages. Each paper is fully refereed, being read by at least two members of the editorial board and usually by an additional expert in the particular subject matter.

The submission of an article to CL for refereeing means that the author certifies the manuscript is not copyrighted; nor has it been published or submitted for publication to another refereed journal. If any version of the paper has appeared, or will appear, in a non-refereed publication, the details of such publication must be made known to the Editor at the time of submission. The final version of a paper tentatively accepted for publication must be accompanied by a Copyright Transfer Agreement signed by all of the authors or, in the case of a "work for hire," by the employer. This written transfer is necessary under the 1978 U.S. Copyright law.

TECHNICAL CORRESPONDENCE: This category includes short articles reporting preliminary results of some project in progress, or the results of other studies of interest to the readership. Technical correspondences should not generally exceed eight double-spaced pages. Each technical correspondence is reviewed by at least two members of the editorial board before acceptance.

LETTERS TO THE EDITOR: This includes statements of opinion on issues relevant to the readership. The Editor and the editorial board will evaluate the appropriateness of these contributions for inclusion.
