*The data collection protocol did not require ethics review board approval because the majority of the annotations were generated through automatic annotation methods, eliminating direct human participation in the labeling process. Additionally, the human annotations were provided by the Hrant Dink Foundation (HDF) as part of their existing work on hate speech detection. Since HDV conducted and managed the annotation process independently, our project did not involve direct recruitment or interaction with annotators, nor did it introduce new ethical considerations beyond those already addressed by HDF.*
